### REGULAR MONTHLY BOARD MEETING

January 28, 2021

A meeting of the Chariton Valley Electric Cooperative, Inc. (CVEC) Board of Directors was called to order at the Cooperative office in Albia, Iowa, on January 28, 2021, at 6:03 p.m. by President Kenny VandenBerg.
